- 10.1. Hospitality Committee: Because neither Hospitality elder was at the meeting, Bill Bussell highlighted the paragraph in this committee's November 15, 2016 minutes which states that the sermon radio broadcasts will be discontinued at the end of this year.
- 10.2. Nominations Committee: Neither Nominations elder was present at the meeting.

- 10.2.1. Upon motion, session approved this committee's recommended 2017 committee assignments:

- 10.2.2. The motion also approved the following nominees to be submitted to the congregation to serve as members-at-large on the church's Nominations Committee in 2017: Dottie Bennink, Bill Bussell, Sally Dunn, and Courtney Ransford.
- 10.3. Personnel Committee: Neither Personnel elder was present. Bill Bussell reporting:
 - 10.3.1. Upon motion, session approved Personnel's recommendation to change the staff's health insurance provider to a Board of Pension's EPO ("Silver") Plan and to change the percentage of employee participation in the cost. Although the employees' percentage increases, their actual payroll deductions decrease due to lower premiums.
 - 10.3.2. Upon motion, session approved reducing Karen Neinhouse's weekly hours from twenty-five to twenty at her request.
 - 10.3.3. These two actions will reduce the church's personnel costs by approximately \$18,500 annually.
- 10.4. Trustees Committee: Lee Brink reporting:
 - 10.4.1. Then committee's minutes include an updated project list and their status.
 - 10.4.2. Carpet replacement for three classrooms will cost \$7856 and will be paid from the Capital Campaign Fund.
 - 10.4.3. Brotherhood Mutual was selected to carry the church's casualty and liability insurance.
 - 10.4.4. The committee's minutes also includes a report from the November 13 brainstorming about the potential future uses of the TCM property.
 - 10.4.5. Andrew LeFurge discussed the gap between the "dream" expenditure budget and projected 2017 receipts. Each committee is asked to revisit its 2017 budget with a target reduction of 10 to 12 percent in total expenses. Also, the committees are asked to investigate if designated and/or restricted funds under their control can be used for part of their 2017 expenditures.
 - 10.4.6. Lee presented and reviewed a summary list of proposed Standard Practice Bulletin revisions. It was agreed that SPB's 3.2 and 3.4 are not part of tonight's discussion and consideration. Motion to approve the following items from this summary:
 - 10.4.7. Items 1 through 9
 - 10.4.8. Items 11 and 12
 - 10.4.9. The paragraph relating to Alpha Distributions Fund
 - 10.4.10. An amendment was offered to change the Alpha Distributions Fund description to add the words "but are not restricted to special projects and new program start-up costs" to the new text. The amendment was approved and the amended motion was approved.
- 10.5. Upon motion and support, session accepted the reports of the Hospitality, Nominations, Personnel, and Trustees Committees.

11. **Unfinished Business:** The meeting docket listed "Standard Practices Bulletins" as unfinished business. This was addressed in part by the Trustees in paragraph 10.4.6 above and will be listed again on the January 9, 2017 session meeting docket under unfinished business.
